Direct Peace Talks to Resume

After months of intense diplomacy, Secretary of State Kerry has achieved a diplomatic breakthrough: for the first time in three years, it appears that Israelis and Palestinians are going to engage in direct peace negotiations. Despite hesitation on both sides, the restart of direct negotiations signals that Secretary Kerry believes that the parties are close enough to merit peace talks.

We <u>remain committed</u> to the pursuit of peace in the Middle East, and commend Secretary Kerry for his diplomacy. These college and high school students not only learned about issues of concern to WRJ and the Reform Movement, but also shared their knowledge and concerns with elected officials and their staff members across Capitol Hill.

August Recess Visits: Last Chance!

A few weeks ago, we wrote telling you about August recess – when members of Congress go home to their districts to hear what matters are most important to their constituents. This year, recess will take place from August 3 through September 8. During this time period, many members of Congress will hold town hall meetings in their home districts, where members of the public can ask questions about pertinent topics. Call your Senators' and Representative's office at 202-224-3121 and ask if there is going to be a town hall meeting opportunity in an area near you.

You can also request a meeting with your member of Congress for your congregation, your Sisterhood, or even just yourself! Many <u>Senators</u> and <u>Representatives</u> have scheduling request forms on their websites – if not, you can always call their office at 202-224-3121 and ask to speak to the Scheduler. Tell the Scheduler that you are a constituent and want to meet with your Member when they are home over recess.

You can talk to your Member about <u>any social justice topic!</u> Pertinent policy issues that are WRJ priorities right now are <u>immigration</u> (particularly in the House of Representatives), <u>gun violence prevention</u> and <u>women's health</u>. Relaying WRJ priorities can help form legislators' opinions, and can raise the profile of these issues for our representatives. Tell your member the principles important to WRJ (which can be found in our <u>resolutions</u> on the topic), ask them what concerns they have about pending legislation, and – most importantly! – ask what you can do as a member of your Sisterhood to help advance this important issue.
